- 1. Must be UKC Registered.
- 2. Must fill out **this** Special TRKC **registration form** and must include a copy of UKC registration or copy of easy entry card with date of birth.
- 3. Dog must be at least 9 years of age on show date.
- 4. Dogs will compete after BIS #2 on Saturday.
- 5. DOS Entry fee \$10 Pre-Entries \$8. DOS Entries Close at 2:00PM on Saturday.
- 6. Must be able to be examined and to move on a lead in the ring without being carried! Breed DQ's or EF's not applicable except for viciousness. Spay or neuter acceptable.
